#### I. STATEMENT OF FACTS

The Receiver, Kevin Dooley Kent ("Receiver"), was appointed by Order of this Court dated June 29, 2020 ("Receivership Order"). (ECF No. 22). The Receivership Order authorized the Receiver to retain Conrad O'Brien as his counsel, and set forth certain obligations of the Receiver and his Retained Personnel, including Conrad O'Brien. Receivership Order, ¶¶ 71-81. The Receivership Order authorized payments to the Receiver and Conrad O'Brien for expenses and hourly fees at approved rates. See id., ¶ 79. The Court has entered subsequent orders authorizing payments to Conrad O'Brien as counsel for expense reimbursement and attorney's fees on a contingency fee basis in certain ancillary litigation. See Order Approving the Receiver's Second and Third Motions for Permission to Initiate Litigation on Behalf of the Receivership Estate (ECF Nos. 161, 167). Additionally, the Receiver anticipates filing a Ninth Interim Fee Application for the period July 1, 2022 through September 30, 2022 in the near future.

On September 16, 2022, the Receiver filed a letter with the Court advising that the Receiver was moving from Conrad O'Brien to Clark Hill. (ECF No. 205). The Receiver moved to Clark Hill on October 1, 2022. *Id.* Conrad O'Brien continued to act as his counsel since that time. However, on or about February 1, 2023, Conrad O'Brien attorneys will be joining Clark Hill, including Andrew S.

Gallinaro and Robin S. Weiss, and Conrad O'Brien will cease to operate in its own name. The Receiver therefore respectfully submits this request for permission to change his counsel from Conrad O'Brien to Clark Hill effective February 1, 2023, and for any order authorizing payment to Conrad O'Brien in connection with this matter or any ancillary litigation be amended to allow for payment to Clark Hill as counsel.

#### II. ARGUMENT

Since it is anticipated that the Receiver's current counsel – Conrad O'Brien – will move as a group to Clark Hill, the Receiver believes it would be prudent to obtain an order permitting him to retain Clark Hill as counsel, and amending all prior and future orders referencing Conrad O'Brien to also apply to Clark Hill as of February 1, 2023. Since it is possible that the date will change, the Receiver is requesting an order that recognizes that all orders referring to Conrad O'Brien, including any orders that may be issued on already-pending motions, will apply equally to Clark Hill upon the effective date of the move, and that the Receiver need not submit amended orders in connection with any motions already pending or that may be filed prior to the effective date.

Given that the same attorneys will continue to represent the Receiver following the move, he does not expect any material change in their representation of the Receiver in this action or the ancillary litigation, or disruption in

Receivership operations. Counsel will continue to adhere to the same obligations at Clark Hill to which they have been subject in this matter, and will ensure that appropriate ethical obligations are followed.<sup>1</sup>

Counsel for the Securities and Exchange Commission has advised that they do not oppose this motion.

#### III. CONCLUSION

In light of all of the foregoing, it is respectfully requested that the Motion of Receiver, Kevin Dooley Kent, for Permission to Change Counsel be granted, and that an order be entered in the form proposed.
