I. STATEMENT OF FACTS

The Receiver, Kevin Dooley Kent ("Receiver"), was appointed by Order of this Court dated June 29, 2020 ("Receivership Order"). (ECF No. 22). The Receivership Order provides that the Receiver "shall establish one or more custodial accounts at Bank of America, a federally insured bank, to receive and hold all cash equivalent Receivership Assets (the "Receivership Funds"). Receivership, Order, ¶ 43. In accordance with the Receivership Order, the Receiver opened a bank account with Bank of America to hold all cash Receivership Assets immediately following his appointment (the "Receivership Account"). The Receiver files this motion to seek an amendment of the Receivership Order, to enable him to establish a custodial account with WSFS Bank or another federally insured bank with a presence in New Jersey to hold the Receivership Funds.

II. ARGUMENT

At the time the Receiver opened the Receivership Account, an EIN was not yet available for the Receivership Estate as a Qualified Settlement Fund ("QSF"). Therefore, the Receiver had to open the Receivership Account under Conrad O'Brien's EIN. The Receiver has previously attempted to have Bank of America change the EIN on the account to the QSF's EIN once it became available, but Bank of America is not willing or able to change the EIN on the account to the

QSF's EIN, and has advised that the Receiver must instead close the Receivership

Account and open a new one.

Given that the Receiver will need to open a new account that is not under

Conrad O'Brien's EIN anyway due to his Counsel's upcoming move to Clark Hill,

PLC (see ECF No. 219), and that based on recent discussions with WSFS the

Receiver anticipates getting enhanced customer service from WSFS (which is also

federally insured and has locations in New Jersey), the Receiver respectfully seeks

an amendment of the Receivership Order permitting him to open a custodial

account(s) with WSFS (or another federally-insured bank with a presence in New

Jersey, if necessary) to hold the Receivership Funds.

Counsel for the Securities and Exchange Commission has advised that they

do not oppose this motion.

III. CONCLUSION

In light of all of the foregoing, it is respectfully requested that the Motion of

Receiver, Kevin Dooley Kent, for Permission to Change Banks be granted, and that

an order be entered in the form proposed.
